PARKING NOTICE

Parking on city property or within intersections is not allowed. These areas must remain clear for safety and access. A deputy will be issuing **warning notices initially**, with enforcement to follow if violations continue.

Winter Reminder: During snow events, please remember to park as far off the City streets as possible. This allows for snow plows and other snow clearing machinery/vehicles to clear our streets safely and efficiently, and help keep our residents as safe as possible.



January Gardening Tips:

January is a great time to protect plants and plan ahead. *Mulch around trees and perennials to insulate roots, and cover tender plants during hard freezes. *Prune dormant fruit trees and remove dead or damaged branches. *Water sparingly during dry periods when temperatures are above freezing, especially for evergreens. *Stay off frozen or soggy lawns to prevent damage, and use this quieter month to plan garden layouts and order seeds for spring.
