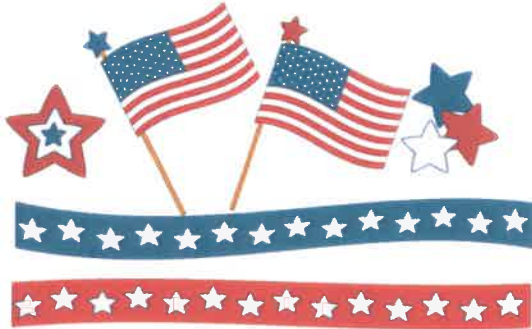

FROM YOUR CITY COUNCIL:



AS SUMMER DRAWS TO A CLOSE we are diligently working on city improvement projects. Walter has done extensive work on the city water system taking advantage of the time Brown Construction had our sidewalks torn apart, to repair and replace some of your aging water pipes. He was also able to identify and repair a major leak we had at the North end of town. I know we are all very grateful for his efforts in keeping our water system safe and functioning properly.

MOVING FORWARD ON PAVING PROJECT

We will be chip sealing all the currently paved streets. Please note the date when posted, because all cars parked on or along city right-of-way will need to be removed to avoid being coated in oil and rock. The exact date will be posted on our website and at the post office as soon as it is confirmed, probably the 2nd or 3rd week of September.

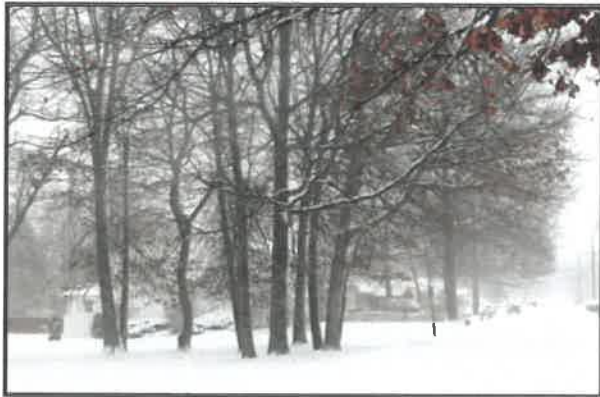
